ANNEX: BRISWA 2.0 Project Description

The BRISWA 2.0 project aims to answer the question: Is it possible to teach about racism in higher education from a systemic perspective? The partnership believes that the answer is affirmative by using a systemic approach to understand racism, by developing tools that will allow students to experiment freely with the knowledge and finally by providing them a training forum where they can test their knowledge in a simulation pilot training.

To achieve the objectives of the project, several activities have been envisaged, which include:

- Studying socio-policy elements of racism, past policy efforts to combat it and identifying the educational needs of universities on the subject
- Developing the material of the BRISWA 2.0 course
- Teaching the course at different universities around Europe
- Disseminating the project and developing an anti-racism campaign that will run for the entire project

Tangible outcomes of the project include the following:

- Report on Educational needs of universities on teaching about racism
